1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and Location	The subjects are situated at Alturlie Point with uninterrupted views to the
	front of the property of the Moray Firth and the Kessock Bridge beyond.
	Surrounding properties are of a mixed age and type. The situation is
	convenient for all amenities and facilities available within Inverness, which
	lies within ready commuting distance.

Age (Year Built)	1997
Weather	The weather was dry and sunny at the time of inspection.

Chimney Stacks There is a rendered blockwork chimney stack with metal flashings. Visually inspected with the aid of binoculars where appropriate.

Roofing including Roof Space	The roof is of a pitched, ridged design comprising timber rafters clad with concrete tiles, incorporating a tiled ridge. There is a timber clad dormer window projection which is contained under a sloping tiled roof covering.
	Access into the roof void areas were undertaken via ceiling hatches within a bedroom and the master bedroom dressing room.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Rainwater Fittings	Gutters and downpipes are of uPVC manufacture.
	Visually inspected with the aid of binoculars where appropriate.

Main Walls	The main walls are of cavity construction with an inner load bearing leaf
	of timber framing and an outer leaf of rendered concrete blockwork and
	an area of stonework detailing. The basecourse is finished in a smooth
	render and incorporates sub floor ventilation.
	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and Joinery	The windows are of a sealed unit, double glazed, uPVC pattern. There are a number of timber casement skylight windows.
	The front and rear entrance doors, including the sets of patio doors within the living room, sitting room and kitchen are of a uPVC and glazed manufacture.
	Roofline soffits and fascia boards are formed in timber.
	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.
External Decorations	The external decorations are of a painted finish.
	Visually inspected.
Conservatories / Porches	The entrance porch is of a similar construction to the main dwelling, contained under a pitched and tiled roof covering.
	Visually inspected.
Communal Areas	Not applicable.
Garages and Permanent Outbuildings	Within the garden areas there is a workshop and two timber sheds, all of timber manufacture and contained under felt roof coverings. Attached to one of the sheds there is a log store of timber manufacture. Visually inspected.

Outside Areas and Boundaries

There is garden ground lying to the front, side and rear of the property which we understand extends to approximately 0.9 acres or thereby. Garden areas are laid to grass, gravel and paving with an area of timber decking to the front.

There is a tarmacadam surfaced driveway which provides ample off street parking provision.

The boundaries are formed in timber fencing and post and wire fencing. Visually inspected.

Ceilings

The ceilings are plasterboard lined with painted finishes.

Visually inspected from floor level.

Internal Walls

The internal walls are plasterboard lined with painted finishes.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors Including Sub-Floors

Flooring is of suspended timber construction throughout.

No access was obtained into the sub floor area.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Internal Joinery and Kitchen Fittings	The internal joinery is of a varnished/painted timber pattern comprising timber panel and glazed timber doors.
	The stairs and balustrades are of timber manufacture.
	There is a modern fitted kitchen which has both floor and wall mounted units.
	Built-in cupboards were looked into but no stored items were moved.
	Kitchen units were visually inspected excluding appliances.
Chimney Breasts and Fireplaces	There is a `Rais` multi fuel stove installed at the fireplace within the living room which comprises a brick surround and a slate hearth.
	Visually inspected. No testing of the flues or fittings was carried out.
Internal Decorations	The internal decorations are painted.
	Visually inspected.
Cellars	Not applicable.
Electricity	Mains electricity is connected.
	The electricity meters and consumer unit are located within a hall cupboard.
	There are three separate arrays of photovoltaic panels installed to the front roof pitch which comprise 16 panels in total. We understand that these benefit from the feed in tariff.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas	Not applicable.

Water, Plumbing and Bathroom Fittings

Water is from the main supply. The plumbing installation where visible, comprises copper distribution pipes together with uPVC wastepipes.

There is a white four piece en suite bathroom suite which comprises a bath, mixer shower, wash hand basin and WC. There are two further three piece en suite shower room facilities, both having mixer showers installed.

Located off the hall there is WC cloakroom which comprises a wash hand basin and WC.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water

There is a full oil fired central heating system which supplies a series of water filled radiators.

Domestic hot water is provided by the `Grant Vortex` central heating boiler which is installed within the utility room, supplemented by a hot water tank which is located within a hall cupboard.

The oil storage tank is of uPVC manufacture and located to the side of the property.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage	Drainage is to a private septic tank which is located within the front garden area.
	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms	There are smoke/fire alarms installed.
	Visually inspected.
	No tests whatsoever were carried out to the system or appliances.
	New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

The property was fully furnished at the time of our inspection and the services were not tested.

No access was obtained to sub-floor areas.

Not all windows and doors were tested at the time of inspection.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.

Notes	We understand that the uPVC windows were replaced in 2016. Peeling lacquer finishes were noted at a number of the skylight windows.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Drainage, we understand is to an exclusive septic tank which lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

There is a shared access at road entrance leading to the property. Your conveyancer should check the legal arrangements are adequate.

The property is fitted with solar/photovoltaic panels supplying electricity back to the National Grid. All documentation relating to the system should be obtained so the transfer of ownership can be carried out as part of the conveyancing process.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Estimated Reinstatement Cost for Insurance Purposes

£715,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £715,000 (SEVEN HUNDRED AND FIFTEEN THOUSAND POUNDS STERLING).

Valuation and Market Comments

£625,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £625,000 (SIX HUNDRED AND TWENTY FIVE THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. No

1.2 The Report



The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 





The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 34 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

2 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
